Donor Privacy Policy

PURPOSE

Maintenance of the trust and confidence of donors and prospective donors is of paramount importance to the Battered Women's Legal Advocacy Project DBA Standpoint. The purpose of this Donor Privacy Policy is to provide transparency as to Standpoint's practices, policies, and procedures for the collection, use, and protection of information relating to donors and prospective donors.

CONSENT

This Donor Privacy Policy applies to collection, use, and protection of information, including information collected on our website. By submitting your information to us or any of our staff, you consent to the terms and conditions of the Policy and to our processing of personal information for the purposes stated below.

PERSONAL INFORMATION

"Personal Information" is information that identifies you personally, such as your name, address, telephone number, and email address. We collect and store the personal information you have provided us. For example:

- When you request information via one of the email addresses identified on our website or otherwise contact us in person, by phone or email, with a question, we may then collect your name, address, and email in order to respond to that inquiry.
- When you register for an event or a training we may collect your name, email address, and other contact information.
- When you make a contribution on our website or another on-line platform, over the phone, or by mailing in a check, we may collect your name, email address, telephone number, and payment information.

While donors have a variety of options for donating electronically to Standpoint, we do not collect or receive any credit-card information from donors electronically. We work with third-party services, including, but not limited to, Paypal, GiveMN, Benevity, Give Lively, Fidelity, Facebook, United Way, and Your Cause. All of these third-party services use industry standard security measures to protect against the loss, misuse, and alteration of the information under its control. These services do not share any financial information with Standpoint and share only the personal information the donors choose to provide to Standpoint.

If a donor or prospective donor provides payment information to Standpoint directly, we will use this information only to process a donation or event registration and then will shred.

USE AND DISCLOSURE OF PERSONAL INFORMATION

In general, Standpoint uses donor information to administer and expand our charitable activities and to communicate with our donors about our program and impact. With respect to the personal information Standpoint collects,

- We will not sell, trade, or share your personal information, collected on the website or through any other business activities with anyone else.
- We will not send you mailings on behalf of other organizations.
- We will only share your personal information if you give us specific permission to do so.
- We will use your personal information to comply with the law or in the good faith belief that such action is necessary to conform to the requirements of law or comply with legal process served on us, protect and defend our rights, or act in urgent circumstances to protect the personal safety of others.

DONOR RECOGNITION

Donor contributions may be publicized in donor recognition materials produced by Standpoint, including print, spoken, and/or web-based media. ACCESS TO RECORDS

RELATION TO OTHER POLICIES

This policy is intended to amplify our practices related to information on our donors and prospective donors and is not intended to supersede other Standpoint policies which may address the collection, use, and/or protection of donor information. In instances where there may be a conflict between policies, the terms of this Donor Privacy Policy shall control.

CHANGES TO THE DONOR PRIVACY POLICY

Standpoint reserves the right to amend and modify this Donor Privacy Policy from time to time with or without notice to donors or prospective donors.
